

Limited Home Rule Demanded

APPLETON, Wis. (AP) — Limited home rule for counties was demanded in a strongly worded resolution adopted by the Wisconsin County Boards Association at its annual state convention Tuesday.

"Dynamic growth and changing demands for additional and adequate service to county residents, brought on by our teeming cities and expanding suburbs, are being stymied by the restrictive constitution and statutes," it said.

The proposal was submitted by Dane County. It calls for introduction of enabling legislation at the next session of the Legislature.

Limited home rule presently is extended only to counties with populations of 500,000 persons or more. Milwaukee is the only Wisconsin county in that class.

In another resolution, the association went on record favoring legislation which would permit county welfare departments to provide family planning and birth control information to all persons requesting it.

Other resolutions adopted by the delegates proposed that state statutes be changed to require a three-fourths vote by county boards to adopt the initial resolution for a bond issue; that the legislature rescind the closing of county teachers colleges in 1971; that the state take over all maintenance costs of the two-year university campuses in the state; that the legislature permit counties to impose a real estate transfer fee to replace the federal tax stamp, and that the legislature permit county zoning officers to issue septic tank permits.

Myron P. Lotto of rural De Pere was elected president of the County Boards association to succeed Ray Blank of Ozaukee County. Other new officers elected were Lloyd C. Owens, Waukesha, vice president, and Clinton S. Pierce, Brodhead, secretary-treasurer.

McCarthy Not To Be on Ballot

MADISON, Wis. (AP) — Sen. Eugene J. McCarthy's name cannot be placed on the Wisconsin ballot for the Nov. 5 presidential election, the state Supreme Court ruled Tuesday.

The court said a petition asking that the Minnesota senator's name be placed on the ballot was denied on its merits. It added that an opinion would be filed at a later date.

The petition asked that New York Mayor John Lindsay, a Republican, be listed as the Democratic lawbreaker's running mate.

A group called Americans for a New America had filed petitions last week with the secretary of state's office containing the necessary number of signatures to nominate McCarthy. But stipulations by the nominees that they would qualify for the offices if elected, were not filed.

The office rejected the petitions.

Earlier the court had agreed to make a quick decision because the secretary of state's office is preparing to send county clerks the names of candidates for the fall ballot.

Jay Sykes of Milwaukee, backer of the independent ticket, told the court stipulations of willingness to serve were not needed to qualify the pair as candidates.

"The United States Constitution is quite clear that presidents are elected by electors," Sykes said.

Asst. Atty. Gen. William Eich countered that state law requires a candidate to affirm that he is qualified to serve.

"The voters are entitled to know this in advance," he said. McCarthy has asked that his name not be placed on the ballot in other states.

Boy's Leg Is Removed

MARSHFIELD, Wis. (AP) — Surgeons who reattached the right leg of 14-year-old Richard Leonard after it was severed in a car-bicycle accident were forced to remove it Tuesday when complications developed.

The leg was amputated below the knee. St. Joseph's hospital reported the boy's condition as satisfactory today. But the condition of 12-year-old Richard Krohn, who was riding on the bicycle with Leonard when it was struck by an automobile was still listed as critical.

The accident occurred last Friday night near Spencer. Both boys live in the rural Spencer area.

The Gustafson girl was one of 14 witnesses to testify at yesterday's hearing.

Just prior to the noon recess, Jean Piolla of Ironwood Township, a bartender at the Lake Road Tavern, testified that Pearson first came into the tavern the day of March 16 about 4:30 p.m., had several drinks and then left. She said he came in again, about an hour later, to use the restroom, but left without ordering a drink. She said he did not come back to the bar until about 10:20 that evening.

She testified that Maurin was an infrequent patron of the tavern and was not a steady customer.

Other witnesses who testified yesterday included Mrs. Gerald D. Olson, daughter of the tavern's owner, who was in the bar at the time, and two other customers, Axel Puisto and John Koski, all of Ironwood Township. Puisto, it was brought out in testimony, was one of two men who helped subdue Pearson.

Testifying at the session Tuesday afternoon in addition to the Gustafson girl were Dr. Bela Gallo of Ironwood, who treated Pearson at Grand View Hospital for what he described as a minor head wound; Dr. F. J. Santini of Ironwood, who testified that he treated two gunshot victims but not Pearson, and Philip Cormier of Wakefield, who took Pearson to the hospital in his ambulance for treatment of the head wound.

Each of these witnesses was asked by Larson if the defendant appeared drunk or incoherent at the time. All of them said it was impossible to tell if Pearson was drunk or had been drinking because his clothes emanated an odor of alcohol as a result of his being struck over the head with a whiskey bottle at the tavern.

Also called to testify were two officers of the sheriff's department, Richard Bennetts and David Berkovitz. Bennetts said that when he arrived at the tavern and was putting the handcuffs on Pearson after being told what happened, he said the defendant said "hello Dick Bennetts, give me a drink." Berkovitz said that while enroute to the hospital in the ambulance, Pearson told him, "don't worry about the Viet Cong," and uttered something about "the Communists in Ironwood Township."

Others called to testify included Dennis O'Leary of 913 Cloverland Drive, Ironwood, who said he had spent the entire afternoon and early part of the evening with Maurin; John Hein of Ironwood, X-ray technician at Grand View Hospital, who took X-rays of Pearson's head injury; Troopers Frank Francisco and Gordon Moyle of the Michigan state police post at Wakefield who provided Pearson with transportation to the county jail from the hospital; Darrell Hautala of Milwaukee, son of the tavern owner; Gerald D. Olson, who was in the bar at the time; Deputy Harry Felix of the sheriff's department, and John Hautala of Ironwood Township.

Bishop Ordered Out of Diocese

DENVER, Colo. (AP) — The bishop of the Episcopal Diocese of Colorado, said to be too ill to face a church trial on charges of breaching his ordination vows, was ordered Tuesday to surrender his ecclesiastical authority and leave the diocese.

The decree was handed down by the nine-bishop court before the Rt. Rev. Joseph S. Minnis, 64, ever actually came trial. It followed testimony from the bishop's physician that Minnis suffers from a serious, aggravated heart condition, and to appear at the trial "would place the bishop's life in peril."

The order gives Bishop Minnis until Oct. 15 to leave the diocese — in this case the state of Colorado — and permits him to return only with prior permission of the presiding bishop.

The church court was closed to press and public just after the bishops convened Monday and before the specific nature of the charges was disclosed. Bishop Minnis, however, has termed them a "pack of lies."

The order was issued before any action was taken on the charges. However, several witnesses, mostly women, had been called and remain under subpoena.

The Rt. Rev. Edwin Thayer, suffragan bishop, now assumes leadership of Colorado's 45,000 Episcopalians.

There was no immediate word from Bishop Minnis on his plans.

Bishop Minnis, reportedly hospitalized in Colorado Springs south of here, did not appear at any of the court sessions.

He would be banished from the diocese under this section of the decree.

"That Joseph Summerville Minnis physically absent himself from the diocese of Colorado as soon as reasonably possible and no later than Oct. 15, not to return thereto without leave of the presiding bishop."

Bishop John S. Higgins of Rhode Island, the presiding judge, said Minnis' physician testified "clearly that for Bishop Minnis to appear before this court for trial would place the bishop's life in peril and... it is probable that Bishop Minnis will never for the rest of his life be able to stand before this court for trial without such peril."

Student Play Is Canceled

MADISON, Wis. (AP) — A student production of the musical Peter Pan — one which included six nude coeds — is headed back to Never-Never Land.

Fears that police would halt the second performance of the show in the University of Wisconsin student union prompted the action by the cast Tuesday.

Stuart A. Gordon, Chicago, senior who directed the production, said the group decided to scrap the show rather than risk arrest or clothe the coeds.

Wisconsin's obscenity laws carry maximum penalties of a \$5,000 fine and five years in jail.

"We attempted to present something we thought was beautiful," said Gordon. "Every one who saw it appreciated it."

A standing-room-only crowd of about 150 students jammed into the union's play circle for the opening performance Monday night. The show included a 10-minute scene in which the unclad coeds portrayed the creation of Never-Never Land.

Shortly before Tuesday's scheduled matinee, Gordon announced the cast was postponing the show because of a warning from the university about the possibility of police intervention.

Chancellor Edwin Young said he informed William Dawson, university theater director, that everyone involved in the play should be informed of the legal implications involved.

"I'm no expert in this area," Young said. "I'm interested in protecting the students."

Gordon said the several members of the cast who voted against going ahead with the matinee did not include the dancing girls.

"It's ironic that the point of Peter Pan is how a person's innocence and ideals can be stripped away by society," Gordon added.

In Gordon's version of the play by J. M. Barrie, the pirates are portrayed by brutal policemen, Tinkerbell dies, and Peter Pan leaves Never-Never Land and becomes an adult.

"But," Romney added, Wallace is "picking up votes that would otherwise be Democrat — principally among the unions."

Asked if he planned to meet with Wallace when the former Alabama governor visits Michigan next week, Romney said: "Oh, is he coming?"

Romney also took issue with a statement by Jackie Robinson that the Nixon-Agnew Republican ticket is racist in its appeal.

"I've made it clear I don't believe that," Romney said. Vice presidential nominee Spiro Agnew has been "just as vigorous in his condemnation of white racism as black racism," Romney said.

The governor added that he would be making several more campaign appearances — in Missouri, Pennsylvania and New Jersey — in behalf of the Republican ticket.

LBJ Imposes Import Quotas

WASHINGTON (AP) — Wisconsin legislators praised President Johnson for imposing emergency quotas on imported dairy products Tuesday, but asked for more permanent action.

"This emergency quota will reduce imports on a temporary basis," said Sen. Gaylord Nelson, D-Wis., "but tighter, across the board quotas are needed to effectively resolve the dairy import problem."

Mr. Johnson issued a presidential proclamation imposing the quotas in an effort to head off rising supplies of milk products from abroad.

The quotas affect imports of cheese, sold mostly by European producers, the Agriculture Department said. The restricted cheese includes processed Edam and Gouda; Emmenthaler; Gruyere process cheese and "other types" listed by U. S. Tariff schedules.

The emergency restrictions will trim the equivalent of about half a billion pounds of milk from what had been expected to total about 2.5 billion pounds in dairy imports for 1968.

Exporting nations affected by the cutback include Denmark, Ireland, The Netherlands, Norway, West Germany, Finland, Switzerland and Austria.

Action came on the recommendation of Agriculture Secretary Orville L. Freeman, who said the nation's dairy program would be hurt without the immediate restrictions.

Mexican Riots Take 15 Lives

MEXICO CITY (AP) — Heavy rain Tuesday night dispersed rioting students whose parts of Mexico City in turmoil for more than 24 hours and left at least 15 persons dead.

Four other deaths were reported Tuesday night during hit-and-run clashes involving students, other dissidents, police and soldiers. But these deaths could not be confirmed.

The fighting Monday night reached a peak not seen in the Mexican capital since the revolutionary days of the 1920s. It slackened off Tuesday, and officials went ahead with preparations for the Olympic Games, scheduled to open in Mexico City on Oct. 12.

Throughout the day Tuesday sirens wailed and shots could be heard as police sought out snipers of fighting around vocational schools in the northwest part of the city, holed up in apartment houses in the area.

Firing increased shortly before night fell, and a magazine reporter on the scene said two students were killed at a vocational school in the downtown Ciudadela section.

At another vocational school in the Tlateloleco area, the scene of heavy fighting Saturday and Monday nights, three buses were burned and police in possession of the school drove back 2,500 students by firing into the air and shooting tear gas into the crowds.

There were also reports of isolated shooting incidents in other parts of the city.

The student unrest, which has plagued Mexico's capital since July 26 and threatens to cut attendance at the Olympics, has been attributed to violation of the right of university autonomy, police brutality, hoodlumism, Communist influences and determination to gain certain concessions from the government.

The autonomy issue was pushed to the forefront last week when the government ordered the army to occupy the University of Mexico, near the Olympic village where 2,000 athletes already are preparing for the games.

LBJ Imposes Import Quotas

WASHINGTON (AP) — Wisconsin legislators praised President Johnson for imposing emergency quotas on imported dairy products Tuesday, but asked for more permanent action.

"This emergency quota will reduce imports on a temporary basis," said Sen. Gaylord Nelson, D-Wis., "but tighter, across the board quotas are needed to effectively resolve the dairy import problem."

Mr. Johnson issued a presidential proclamation imposing the quotas in an effort to head off rising supplies of milk products from abroad.

The quotas affect imports of cheese, sold mostly by European producers, the Agriculture Department said. The restricted cheese includes processed Edam and Gouda; Emmenthaler; Gruyere process cheese and "other types" listed by U. S. Tariff schedules.

The emergency restrictions will trim the equivalent of about half a billion pounds of milk from what had been expected to total about 2.5 billion pounds in dairy imports for 1968.

Exporting nations affected by the cutback include Denmark, Ireland, The Netherlands, Norway, West Germany, Finland, Switzerland and Austria.

Action came on the recommendation of Agriculture Secretary Orville L. Freeman, who said the nation's dairy program would be hurt without the immediate restrictions.

Mexican Riots Take 15 Lives

MEXICO CITY (AP) — Heavy rain Tuesday night dispersed rioting students whose parts of Mexico City in turmoil for more than 24 hours and left at least 15 persons dead.

Four other deaths were reported Tuesday night during hit-and-run clashes involving students, other dissidents, police and soldiers. But these deaths could not be confirmed.

The fighting Monday night reached a peak not seen in the Mexican capital since the revolutionary days of the 1920s. It slackened off Tuesday, and officials went ahead with preparations for the Olympic Games, scheduled to open in Mexico City on Oct. 12.

Throughout the day Tuesday sirens wailed and shots could be heard as police sought out snipers of fighting around vocational schools in the northwest part of the city, holed up in apartment houses in the area.

Firing increased shortly before night fell, and a magazine reporter on the scene said two students were killed at a vocational school in the downtown Ciudadela section.

At another vocational school in the Tlateloleco area, the scene of heavy fighting Saturday and Monday nights, three buses were burned and police in possession of the school drove back 2,500 students by firing into the air and shooting tear gas into the crowds.

There were also reports of isolated shooting incidents in other parts of the city.

The student unrest, which has plagued Mexico's capital since July 26 and threatens to cut attendance at the Olympics, has been attributed to violation of the right of university autonomy, police brutality, hoodlumism, Communist influences and determination to gain certain concessions from the government.

The autonomy issue was pushed to the forefront last week when the government ordered the army to occupy the University of Mexico, near the Olympic village where 2,000 athletes already are preparing for the games.
